- Recovery Returning the community to normal










# State-Level Emergency Management

State Emergency Response Team

Comprised of response partners from government agencies voluntary agencies and private organizations.

## **Program Dispensing Options**

- County Health Department Patients
  - CHDs with pharmacies
    - ▶ Utilizing established pharmacy procedures with a valid prescription
  - CHDs without pharmacies
    - ▶ Utilizing established Nurse Issuance protocol and procedures
- Non-County Health Department Patients
  - Retail pharmacies
    - ▶ Chain drug stores
    - ▶ Independent drug stores
  - Hospital pharmacies
  - Private providers



#### Distribution of Antiviral Medications

- All participating pharmacies (both public and private) will continue to fill antivirals:
- Facilitated by the FDOH Bureau of Statewide Pharmaceutical Services
- Normal business practices
  - ▶Ordering
  - ►Storage & Inventory
  - Record keeping & Tracking
  - ▶ Recovery
